

THE PAYCHECK FAIRNESS ACT WOULD HELP CLOSE THE WAGE GAP FOR FLORIDA WOMEN

At the time of the Equal Pay Act's passage in 1963, women earned merely 59 cents to every dollar earned by men.¹ Enforcement of the Equal Pay Act and related civil rights laws has helped to narrow the wage gap, but significant disparities remain and must be addressed. Although Congress has recently taken initial steps to improve the laws that govern pay discrimination by passing the Lilly Ledbetter Fair Pay Act of 2009,² there is more than must be done to realize the decades old promise of equal pay for equal work. In particular, the Paycheck Fairness Act would close loopholes in the Equal Pay Act, enhance the procedures and remedies available to challenge violations of the law, and provide the government with tools to monitor and address pay inequities. This bill, which has already passed the House of Representatives, is particularly critical in these economically perilous times, when women and their families are especially vulnerable.

The Gender Wage Gap Persists in Florida

Although the gap between men's and women's wages has narrowed over the past three decades, on average women continue to earn significantly less than men.

- In 2007, on average, women in Florida working full-time, year-round earned only 80% of what men working full-time, year-round earned³ -- two percentage points above the nationwide average of 78%.⁴
- The wage gap is even more substantial when race and gender are considered together. White, non-Hispanic women working full-time, year-round in Florida earned only 78% of the wages of White, non-Hispanic men. However, Black women working full-time, year-round in Florida earned only 58%, and Hispanic women only 57%, of the wages of White, non-Hispanic men.⁵
- The wage gap persists at all levels of education. Women in Florida with a high school diploma earned only 70% of what men with a high school diploma earned. Women in Florida with a bachelor's degree earned only 71% of the amount that men with a bachelor's degree were paid. In fact, the average Florida woman must receive a bachelor's degree before she earns as much as the average Florida male high school graduate.⁶
- The wage gap exists across occupations. For example, Florida women working full-time, year-round in management, business, and finance occupations earned only 72% of what men in the same occupations earned, and Florida women working full-time, year-round in sales and related occupations earned only 75% of what men in the same occupations earned.⁷

Florida Women Are Particularly Vulnerable to Economic Hardship in This Struggling Economy

In the current economic downturn, many Florida residents are facing financial problems, stagnant wages and living standards, and job loss. Women in Florida already have higher rates of economic insecurity – on average they have lower earnings than men (\$23,649 compared to \$31,619 in 2007)⁸ and are more likely to live in poverty (12% of Florida women compared to 9% of men lived in poverty in 2007).⁹ As a result, women may be particularly vulnerable to economic hardship in this struggling economy. For example:

- Women’s lower incomes make it harder for them to make ends meet. Between February of 2008 and February of 2009, the cost of groceries increased 4.7% in the Miami-Fort Lauderdale area and home energy costs increased 6.5%.¹⁰
- Although unemployment rates for men and women are rising nationwide,¹¹ because of their lower earnings, women may have fewer savings to fall back on if they lose their jobs. Worse yet, women who lose their jobs are also less likely than men to receive unemployment insurance benefits.¹² The unemployment rate in Florida in March 2009 was 9.7%, a 102% increase since the recession began in December 2007 and the highest level of state unemployment in 33 years.¹³
- In part because of lower earnings, nationwide about a third of women borrowers receive subprime mortgage loans, compared to only a quarter of male borrowers.¹⁴ As the housing market continues to struggle, women may be more likely to face rising mortgage rates and even foreclosures. In 2008, Florida had 501,396 foreclosure filings, a 133% increase from 2007 and a 411% increase from 2006.¹⁵
- The worsening recession is affecting all Americans, but women – who were already in a more precarious economic position than men because of lower earnings and higher poverty rates – are more likely to rely on public benefits like Medicaid, food stamps, and housing assistance.¹⁶ In 2008, Florida provided food stamp benefits to over 1.4 million children and adults, an increase of over 222,000 from the previous year.¹⁷ Additionally, Florida faces a mid-year FY 2009 budget shortfall of \$2.3 billion and a projected FY 2010 budget gap of \$5.8 billion.¹⁸ Enacted cuts to Medicaid and K-12 or early education as result of these shortfalls¹⁹ disproportionately affect women and create further hardship for Florida women and their families. Without the federal funds provided in the American Recovery and Reinvestment Act, the state would have had to enact spending cuts deeper than it already has.

The Paycheck Fairness Act would help close the wage gap and help women to deal with these economic realities.
