

THE PAYCHECK FAIRNESS ACT WOULD HELP CLOSE THE WAGE GAP FOR IDAHO WOMEN

At the time of the Equal Pay Act's passage in 1963, women earned merely 59 cents to every dollar earned by men. Enforcement of the Equal Pay Act and related civil rights laws has helped to narrow the wage gap, but significant disparities remain and must be addressed. Although Congress has recently taken initial steps to improve the laws that govern pay discrimination by passing the Lilly Ledbetter Fair Pay Act of 2009, there is more than must be done to realize the decades old promise of equal pay for equal work. In particular, the Paycheck Fairness Act would close loopholes in the Equal Pay Act, enhance the procedures and remedies available to challenge violations of the law, and provide the government with tools to monitor and address pay inequities. This bill, which has already passed the House of Representatives, is particularly critical in these economically perilous times, when women and their families are especially vulnerable.

The Gender Wage Gap Persists in Idaho

Although the gap between men's and women's wages has narrowed over the past three decades, on average women continue to earn significantly less than men.

- In 2007, on average, women in Idaho working full-time, year-round earned only 73% of what men working full-time, year-round earned³ -- five percentage points below the nationwide average of 78%.⁴
- The wage gap is even more substantial when race and gender are considered together. White, non-Hispanic women working full-time, year-round in Idaho earned only 72% of the wages of White, non-Hispanic men. However, Hispanic women working full-time, year-round in Idaho earned only 50% of the wages of White, non-Hispanic men.⁵
- The wage gap persists at all levels of education. Women in Idaho with a high school diploma earned only 63% of what men with a high school diploma earned. Women in Idaho with a bachelor's degree earned only 64% of the amount that men with a bachelor's degree were paid. In fact, the average Idaho woman must receive a bachelor's degree before she earns as much as the average Idaho male high school graduate. 6
- The wage gap exists across occupations. For example, Idaho women working full-time, year-round in sales and related occupations earned only 70% of what men in the same occupations earned, and Idaho women working full-time, year-round in architecture and engineering occupations earned only 60% of what men in the same occupations earned.⁷

Idaho Women Are Particularly Vulnerable to Economic Hardship in This Struggling Economy

In the current economic downturn, many Idaho residents are facing financial problems, stagnant wages and living standards, and job loss. Women in Idaho already have higher rates of economic insecurity – on average they have lower earnings than men (\$18,749 compared to \$30,879 in 2007)⁸ and are more likely to live in poverty (13% of Idaho women compared to 8% of men lived in poverty in 2007).⁹ As a result, women may be particularly vulnerable to economic hardship in this struggling economy. For example:

- Women's lower incomes make it harder for them to make ends meet. Between March of 2008 and March of 2009, the cost of groceries increased 3.8% in Idaho and home electricity costs increased 5%.¹⁰
- Although unemployment rates for men and women are rising nationwide,¹¹ because of their lower earnings, women may have fewer savings to fall back on if they lose their job. Worse yet, women who lose their jobs are also less likely than men to receive unemployment insurance benefits.¹² The unemployment rate in Idaho in March 2009 was 7%, a 94% increase since the recession began in December 2007 and the highest level of state unemployment in over 21 years.¹³
- In part because of lower earnings, nationwide about a third of women borrowers receive subprime mortgage loans, compared to only a quarter of male borrowers. ¹⁴ As the housing market continues to struggle, women may be more likely to face rising mortgage rates and even foreclosures. In 2008, Idaho had 11,272 foreclosure filings, an increase of 134% from 2007 and an increase of 302% from 2006. ¹⁵
- The worsening recession is affecting all Americans, but women who were already in a more precarious economic position than men because of lower earnings and higher poverty rates are more likely to rely on public programs and benefits like Medicaid, food stamps, and housing assistance. ¹⁶ In 2008, Idaho provided food stamps to over 100,000 children and adults, an increase of over 13,000 from the previous year. ¹⁷ Additionally, Idaho faces a mid-year FY 2009 budget shortfall of \$218 million and a projected FY 2010 budget gap of \$411 million. ¹⁸ Enacted cuts to Medicaid and the state workforce as a result of these shortfalls ¹⁹ disproportionately affect women and create greater hardship for Idaho women and their families.

The Paycheck Fairness Act would help close the wage gap and help women to deal with these economic realities.
