Strengths of FFN Care

- Often preferred by parents
- Convenient locations
- Flexible hours to match work schedules
- Suitable environment for sleeping
- Small number of children/ easy management
- High level of trust & communication
- Language & culture may match parents'
- Siblings cared for together
- Supports neighborhood and family economy



Weaknesses

- Generally not effective in preparing at-risk 3 5 year olds for school
- Difficult and expensive for agencies to deliver training & information – intensive door to door outreach is required
- Difficult for providers to network with each other





Opportunities

- Combine multiple single-focus initiatives to form a network of services & providers
- Reach FFN providers & children through Preschool for All
- Conduct research to get us beyond stereotypes
 & suggest new ways to connect families with providers of all kinds.



Concerns

 State prekindergarten/ Universal PreK funding will be directed to less needy children in centers before reaching more needy, more isolated children in FFN care

Accessing State PreK Funds

Community Connections

- Community asset model
- Links care & education across settings
- 3-5 year old children are taken to a part-day State PreK classroom 4 days/week
- 5th day teachers visit FFN home w/ books & activities
- Funded by State PreK @ \$3,000 per child
- FFN providers receive full day child care assistance payments



Community Connections (cont.)

Illinois Action for Children staff:

- Identify target neighborhoods
- Find child care center to host classroom
- Apply for state Preschool for All funding
- Provide training & TA to child care center
- Provide training and resources to child care providers
- Partner with community groups to connect with home based child care providers – both FFN and licensed homes.
- Organize fun events community festivals, museum visits, etc for families and providers



Community Connections (cont.)

Child care center staff:

- Enroll children
- Operate classroom-based program
- Visit each home twice monthly





Community Connections (cont.)

Benefits for FFN care:

- Children remain in FFN care, but also get a classroom experience
- State PreK funding helps support FFN care
- FFN care quality improves for 3-5 year old children
- FFN care quality improves for children birth to 3
- Parent satisfaction increases
- Provider sense of competence increases

Working with NCCP to help shape Community Connections model & guide replication

 - Obstacles & needed changes
 - Are we ready to examine results?

Results

- Did State PreK reach FFN children? Did children attend?
