We have had many discussions the past months about regulations being issued to implement the health care law. But what is happening when those regulations reach the states? 3. Federal Navigator Funding and Proposed Rule on Navigators and Assistors

We are only a few months away from the start of open enrollment and that means navigators and assistors will be an increasingly important part of the conversation. HHS recently released a proposed rule on navigators and in person assistors and, just a couple of days ago, announced a funding opportunity for navigator programs in states with Federally Facilitated Exchanges. Anna Benyo will provide a quick review of top issues in the proposed rule, an overview of the funding opportunities, and potential engagement in states with state-run exchanges or for organizations wishing to be engaged without being a navigator.
