## 2. Women's Access to Preventive Services Affirmed by HHS

On February 20, The U.S. Department of Health and Human Services released a set of Frequently Asked Questions (FAQs) on the Section 2713 preventive services provision of the Affordable Care Act, including the women's preventive services. ### 3. Exemptions to Individual Responsibility and Minimum Essential Coverage

On last month's call, we discussed proposed rules released by the U.S. Department of Health and Human Services (HHS) and the Department of Treasury addressing the individual requirement to maintain health insurance. These proposed rules include information on what types of coverage qualify as minimum essential coverage – which is the term for the type of coverage individual need to maintain under the law to avoid a penalty – and exemptions from the requirement. Comments on the HHS rule are due on Monday, March 18 and Danielle Garrett, Health Policy Analyst will discuss the National Women's Law Center template comments and Dania Palanker, Senior Counsel, will discuss additional issues in the Treasury comments.
