STATE CHILD CARE ASSISTANCE POLICIES: NEW HAMPSHIRE

- *Income eligibility limit:* In 2015, a family of three in New Hampshire could qualify for child care assistance with an annual income up to \$49,475 (246 percent of poverty, 60 percent of state median income).¹
- Waiting list: New Hampshire had no waiting list for child care assistance as of February 2015.
- Parent copayments: In 2015, a family of three with an income at 100 percent of poverty (\$20,090 a year) receiving child care assistance in New Hampshire paid \$126 per month, or 7 percent of its income, in copayments. A family of three with an income at 150 percent of poverty (\$30,135 a year) receiving child care assistance paid \$314 per month, or 12 percent of its income, in copayments.
- **Reimbursement rates:** In 2015, New Hampshire's reimbursement rates for child care providers serving families receiving child care assistance were below the federally recommended level—the 75th percentile of current market rates, which is the level designed to give families access to 75 percent of the providers in their community.²
 - New Hampshire's monthly reimbursement rate for center care for a four-year-old was \$736,3 which was \$161 (18 percent) below the 75th percentile of current market rates for this type of care.
- New Hampshire's monthly reimbursement rate for center care for a one-year-old was \$874,⁴ which was \$157 (15 percent) below the 75th percentile of current market rates for this type of care.
- Tiered reimbursement rates: In 2015, New Hampshire paid higher reimbursement rates for higher-quality care.
- The reimbursement rate for center care for a four-year-old at the highest quality tier was 10 percent higher than the rate at the lowest quality tier.
- The reimbursement rate for center care for a four-year-old at the highest quality tier was still below the 75th percentile of current market rates.
- *Eligibility for parents searching for a job:* In 2015, New Hampshire allowed parents to qualify for or continue receiving child care assistance for up to 40 days while searching for a job.⁵

- 1 As of July 2015, the income limit was increased to \$50,225 (250 percent of poverty) to adjust for the 2015 federal poverty level.
- 2 The reimbursement rates shown here are the rates that were in effect as of February 2015. The state increased its base reimbursement rates (from the 50th percentile of 2011 market rates to the 50th percentile of 2014 market rates) as of June 2015.
- 3 The state has higher rates for higher-quality care; this is the base (lowest) rate, which is the most common rate level.
- 4 This is the base (lowest) rate, which is the most common rate level.
- 5 Parents can receive child care assistance while searching for a job for up to 40 days in a 6-month period, for up to 30 hours per week. Parents must verify their job search with either receipt of unemployment compensation, a registration page from the New Hampshire Job Match System, or participation in the New Hampshire Employment Program.
