## STATE CHILD CARE ASSISTANCE POLICIES: *NEW JERSEY*

- **Income eligibility limit:** In 2015, a family of three in New Jersey could qualify for child care assistance with an annual income up to \$39,580 (197 percent of poverty, 45 percent of state median income).<sup>1</sup>
- **Waiting list:** New Jersey had no waiting list for child care assistance as of February 2015.
- **Parent copayments:** In 2015, a family of three with an income at 100 percent of poverty (\$20,090 a year) receiving child care assistance in New Jersey paid \$77 per month, or 5 percent of its income, in copayments. A family of three with an income at 150 percent of poverty (\$30,135 a year) receiving child care assistance paid \$106 per month, or 4 percent of its income, in copayments.
- **Reimbursement rates:** In 2015, New Jersey's reimbursement rates for child care providers serving families receiving child care assistance were below the federally recommended level—the 75th percentile of current market rates, which is the level designed to give families access to 75 percent of the providers in their community.
  - New Jersey's monthly reimbursement rate for center care for a four-year-old was \$573,<sup>2</sup> which was \$333 (37 percent) below the 75th percentile of current market rates for this type of care.
  - New Jersey's monthly reimbursement rate for center care for a one-year-old was \$695,<sup>3</sup> which was \$335 (33 percent) below the 75th percentile of current market rates for this type of care.
- **Tiered reimbursement rates:** In 2015, New Jersey paid higher reimbursement rates for higher-quality care.
  - The reimbursement rate for center care for a four-year-old at the highest quality tier was 5 percent higher than the rate at the lowest quality tier.
  - The reimbursement rate for center care for a four-year-old at the highest quality tier was still below the 75th percentile of current market rates.
- **Eligibility for parents searching for a job:** In 2015, New Jersey allowed parents to continue receiving child care assistance for up to 90 days while searching for a job.<sup>4</sup> However, the state did not allow parents to qualify for child care assistance while searching for a job.

4 Parents receiving child care assistance can continue to receive it after losing a job for up to 90 days from the date of a layoff notice. Parents cannot receive child care assistance while searching for a job if they voluntarily quit employment.
