Earnings are in 2015 dollars. Ranks based on unrounded data. "Age at which white, non-Hispanic women's career earnings at age 60" assumes all workers begin work at age 20. Assuming white, non-Hispanic men have a 40-year career, this is the age at which white, non-Hispanic women are able to retire with the same lifetime earnings as their male counterparts. White, non-Hispanic women and men in both surveys refer to those who have self-identified as white but who are not of Hispanic, Latino, or Spanish origin.
