Helped women secure no-cost coverage of birth control and other essential preventive health services by creating the user-friendly Cover Her hot line, which provides personalized tools to help women navigate the health insurance system and identifies and addresses systemic barriers to achieving coverage. Fought back against the harmful Supreme Court birth control

Family economic security: Helped win federal contractor and state minimum wage increases through a Presidential Executive Order and legislation in four states, by analyzing and disseminating new data, producing materials and infographics highlighting the impact of a higher minimum wage on women-who are two-thirds of minimum-wage workers-working with national and state coalitions, testifying before Congress, and educating the public, Administration officials and lawmakers about what is at stake for women and families. Helped secure minimum wage and overtime pay for home health workers-90 percent of whom are women-by generating thousands of public comments to support the Department of Labor's proposal to provide these basic labor protections. Won nearly \$1.5 billion in new investments in early
