HOW TO ACCESS YOUR BENEFITS UNDER THE AMERICAN RESCUE PLAN

The American Rescue Plan Act and other COVID relief offer important benefits to help you and your family recover from the pandemic. This fact sheet can help you find the benefits you and your families are eligible for this year and next year, including when you file your taxes in early 2022. These tax benefits will not affect your other public benefits, such as Medicaid, nutrition assistance, Social Security disability benefits, rental assistance, or other income supports.

DO YOU HAVE KIDS?

Most families with children are eligible for up to \$3,000 per child (\$3,600 per child under 6) in 2021 from the Child Tax Credit. You can get advance payments every month between July 2021 and December 2021:

- Up to \$250 per child ages 6 to 17
- Up to \$300 per child under 6 years old

Follow these steps to get your money:

- If you filed taxes your 2020 taxes this year or your 2019 taxes last year or used the IRS Non-Filer Portal to get a stimulus check, you will get your payments automatically!
- If you didn't file taxes in the last two years, sign up for monthly payments through the IRS Non-Filer Portal: https://www.irs.gov/creditsdeductions/child-tax-credit-non-filer-sign-uptool. Find more information at childtaxcredit. gov or GetCTC.org.
- The advance payments will only be half of your total credit—file your taxes in early 2022 to get the rest. And you may be eligible for other tax credits as well.

NEED HELP FILING YOUR TAXES IN EARLY 2022?

- If your income is less than \$72,000, file your taxes for free: IRS.gov/individuals/free-taxreturn-preparation-for-qualifying-taxpayers.

DID YOU LOSE YOUR JOB?

Because of the ARP, in some states, you can get an additional \$300 per week until **September 6th**.

NEED HELP PAYING FOR CHILD CARE?

If you have out-of-pocket child care expenses, including for day care, babysitters, and summer camps, you can receive up to \$8,000 when you file your taxes next year.

- Keep track of the child care expenses you pay for each child this year. Find out more about what expenses qualify here: IRS.gov/newsroom/childand-dependent-care-tax-credit-fags.
- File your taxes in early 2022 to receive the credit.

DO YOU NEED A FREE COVID-19 VACCINATION?

You can get the vaccine for free, regardless of health insurance status or immigration status.
