Addressing Educational Barriers Faced by Girls at the Margin

As part of the analysis, the outside consultant reviews the Center's benefits for reasonableness and in comparison to other comparable organizations. The compensation information in the 990s of organizations similar to the Center is also reviewed for comparability.

The Compensation Committee determines the compensation of the President and CEO, based on the outside consultant's report and the compensation information from the 990s of similar organizations, as well as compensation data provided by Brian Vogel and Quatt Associates. All deliberations and decisions of the compensation committee are reflected in contemporaneously drafted and approved minutes of the committee.

In the case of the Co-Presidents Emerita's final compensation (a portion of which is reflected in the current year Schedule J), the Center engaged a consultant who specializes in retirement-related compensation to create a compensation plan. They performed an in-depth review of peer organizations and created a compensation plan that was reviewed by outside counsel prior to extensive deliberation by the Center's Compensation Committee. The Compensation Committee also consulted with other members of the Board of Directors prior to setting the Co-Presidents Emerita's final compensation.
