Re: Nomination of Ketanji Brown Jackson to the Supreme Court of the United States

Dear Majority Leader Schumer, Minority Leader McConnell, Chairman Durbin, and Ranking Member Grassley:

We serve as General Counsel for a broad range of businesses in the United States, and we write in support of the nomination of Ketanji Brown Jackson to the Supreme Court of the United States. We wholeheartedly endorse Judge Jackson's nomination and urge you to grant her fair consideration and a speedy confirmation.

Judge Ketanji Brown Jackson is a renowned jurist and former litigator with an unparalleled commitment to safeguarding Constitutional ideals and promoting equal justice. The thoughtful, methodological approach to the law that brought Judge Jackson such success as a judge and as a litigator would serve her well on the Supreme Court. As a Supreme Court justice, Judge Jackson would approach each case with an open mind, letting the facts, the law and precedent guide her decision-making. The American people deserve a judge like Ketanji Brown Jackson, a judge who will serve her country fairly, impartially, and with a commitment to equal justice under the law.

Judge Jackson is a dedicated public servant and highly respected legal practitioner with an immensely impressive resume. A former clerk for Justice Stephen Breyer, Judge Jackson currently serves on the U.S. Court of Appeals for the District of Columbia, one of this nation's most esteemed courts. Prior to her appointment, Judge Jackson spent eight years serving on the District Court for the District of Columbia. In those eight years, Judge Jackson issued over 550 rulings on issues ranging from labor rights to executive powers. Before becoming a federal judge, she served in multiple public service roles, including Assistant Special Counsel, Commissioner and Vice-Chair of the U.S. Sentencing Commission, where she worked on bipartisan reforms to federal sentencing guidelines. Judge Jackson also spent two years as an Assistant Federal Public Defender and represented indigent criminal appellants before the

D.C. Circuit. Judge Jackson's career history attests to her dedication to the law and to ensuring that the American people have access to a just and impartial judiciary.

By any metric, Judge Jackson is an immensely qualified legal luminary and we are thrilled that she will also make history as the first Black woman justice on the Supreme Court. Of the 115 justices who have served on the Supreme Court, only 5 have been women and only 3 have been people of color. The American people deserve a Supreme Court which reflects the nation's diversity, and this Senate has the opportunity to make that happen. When judges and justices come from a diverse set of backgrounds, courts can better make decisions that reflect a wider variety of perspectives. Moreover, when people see Supreme Court justices who look like them and understand their backgrounds, it increases public confidence in our judicial system. Judge Jackson is the perfect nominee to make history as the first Black woman to serve on the Supreme Court.

We strongly believe that Judge Jackson should sit on the highest court in the land and express our hope that she is promptly confirmed.
