

# Women Gain Nearly Two in Three Jobs Added to Economy in October

The most recent Bureau of Labor Statistics (BLS) data showed that women gained 173,000 jobs in October 2022. 261,000 jobs were added to the economy overall in October, meaning women gained 66.3% of the jobs added last month. This marks 22 months of consecutive job gains for women and means women now hold 294,000 more net jobs now than in February 2020; by comparison, men hold 510,000 more net jobs now than in February 2020.<sup>2</sup>

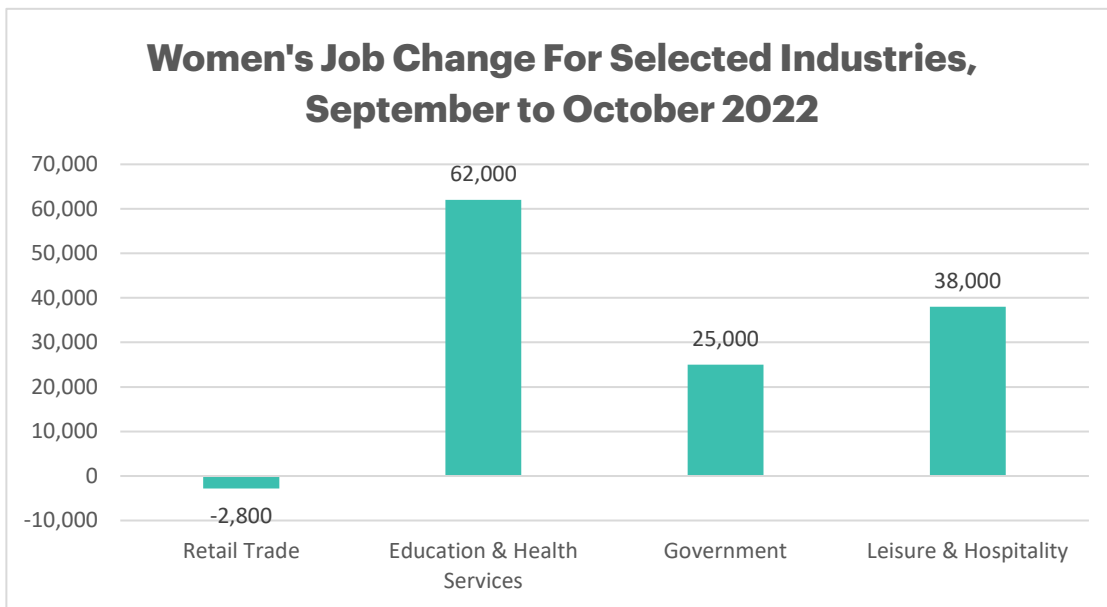
However, the unemployment rate for women ages 20 and over increased from 3.1% in September to 3.4% in October as many women shifted from being employed to unemployed, despite women's job gains.<sup>3</sup> Note that BLS's jobs report data comes from two separate but simultaneously released datasets. Data on jobs added to the economy comes from a survey of businesses, or the Current Employment Survey (CES). Data on unemployment and labor force participation comes from a survey of people, the Current Population Survey (CPS). These surveys complement one another but sometimes tell different stories.

Last month, 9,000 women joined the labor force, meaning they are now either newly working or looking for work. Compared to February 2020, there are still 808,000 fewer women in the labor force. By comparison, 34,000 men left the labor force in October. Despite this loss, there are still 693,000 more men in the labor force now than in February 2020. Women's labor force participation rate was 58.0% in October, unchanged from September, but is more than one percentage point below women's pre-pandemic labor force participation rate of 59.3%. Women make up 100% of net labor force leavers ages 20 and over since February 2020.<sup>4</sup>

## Women gained 173,000 jobs last month and hold 294,000 more net jobs now than they did in February 2020.

- Since February 2020, the economy has experienced a net gain of 804,000 jobs. Men held 510,000 more net jobs while women held 294,000 more net jobs in October 2022 than in February 2020.
- The leisure and hospitality sector gained 35,000 jobs in October 2022. Women gained 38,000 jobs in this sector, meaning they gained all the jobs added, while men lost 3,000<sup>5</sup> — but while leisure and hospitality jobs have been a key driver of the recovery for women, many of these jobs have low wages, unpredictable hours, and minimal benefits.<sup>6</sup> Women make up 53.0% of the leisure and hospitality workforce.

- The retail trade sector gained 7,200 jobs in October 2022. Women lost 2,800 jobs while men gained 10,000 jobs. Women make up 49.0% of the retail trade workforce.
- The government sector gained 28,000 jobs in October 2022. Women gained 25,000 jobs, or 89.3% of the jobs added. Women make up 58.2% of the government workforce.
- The education and health services sector gained 79,000 jobs in October 2022. Women gained 62,000 jobs, or 78.5% of the jobs added. Women make up 77.1% of the education and health services workforce.
- The child care sector lost 4,900 jobs last month. A net 88,400 child care jobs have been lost since February 2020. The child care sector is still missing over 1 in 12 jobs (8.4%) since the start of the crisis<sup>7</sup> — and ongoing staffing shortages in this sector particularly impede an equitable recovery, as they also make it harder for parents to secure the child care they need to work. Women make up 92.6% of the child care workforce.<sup>8</sup>



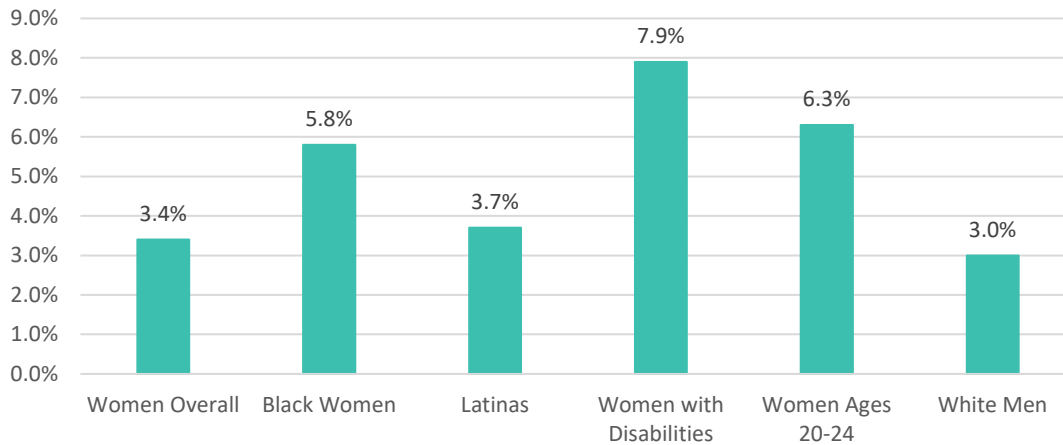

## The overall unemployment rate masks higher rates for Black women, disabled women, and other groups.

- The unemployment rate for women ages 20 and over increased from 3.1% in September to 3.4% in October 2022. The unemployment rate for men ages 20 and over remained unchanged at 3.3%.<sup>9</sup>
- The unemployment rate for Black women ages 20 and over was 5.8% in October 2022, up from 5.4% in September. The unemployment rate for Black men ages 20 and over decreased from 5.8% in September to 5.3% in October 2022.<sup>10</sup>
- The unemployment rate for Latinas ages 20 and over was 3.7% in October 2022, up slightly from 3.6% in September.<sup>11</sup>
- The unemployment rate for Asian women ages 20 and over was 2.4% in October 2022, up from 2.0% in September.<sup>12</sup>
- The unemployment rate for women with disabilities ages 16-64 was 7.9% in October 2022, down from 8.3% in September.<sup>13</sup>
- The unemployment rate for young women ages 20-24 was 6.3% in October 2022, up from 6.0% in September. The unemployment rate for Black women ages 20-24 decreased from 13.5% in September to 12.2% in October 2022.<sup>14</sup>

- By comparison, the unemployment rate for white men ages 20 and over was 3.0% in October 2022, up slightly from 2.9% in September.<sup>15</sup>

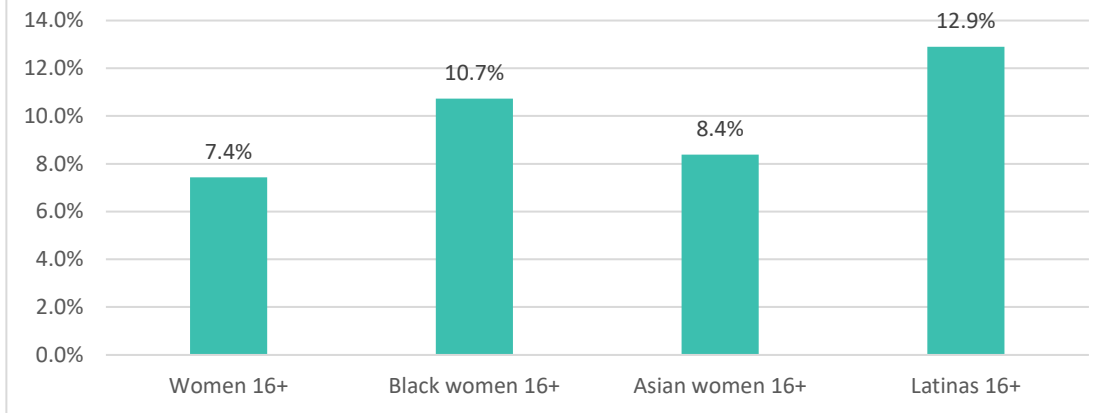
### Many unemployed women have been out of work for 6 months or longer.

In October 2022, more than 1 in 5 unemployed women ages 20 and over (21.5%) had been out of work for six months or longer. Among unemployed women ages 16 and over, 20.5% had been out of work for six months or longer, including 25.6% of unemployed Black women, 24.8% of unemployed Asian women, and 19.1% of unemployed Latinas.<sup>16</sup> Additionally, in October 2022, nearly 1 in 8 unemployed women ages 16 and over (12.4%) had been out of work for a year or longer.<sup>17</sup>

### Many women working part-time are doing so involuntarily.

Over 20.8 million women ages 16 and over were working part time in October. Nearly 1 in 13 (7.4%) were doing so for economic reasons, such as slack business conditions, meaning they wanted to be working more hours but were unable to do so. This includes 12.9% of Latinas ages 16 and over working part time, 10.7% of Black women ages 16 and over working part time, and 8.4% of Asian women ages 16 and over working part time.<sup>18</sup> In addition, many women work part time for reasons that BLS considers “voluntary” but may in fact reflect inadequate access to child care or other supports for working caregivers.<sup>19</sup> Women, especially those with caregiving responsibilities, disproportionately shifted from full-time to part-time work during the pandemic.<sup>20</sup>

However, BLS does not revise past figures with these new estimates and therefore cautions the comparability of figures across years.
