Re: September Child Care Funding Cliff Polling Survey Summary

Date: October 1, 2024

NWLC designed and Morning Consult administered this survey via online panel. The survey reached 4,443 adults nationally, 970 of those are parents with children aged 13 or younger. The survey was conducted September 13- September 15, 2024. The data has been weighted to approximate a target sample of adults based on gender by age, educational attainment, race, marital status, home ownership, race by educational attainment, and region. The margin of error for the sample is +/-1.5% and larger for subgroups. (MOE is 3.11% for parents with young children, 4.8% for parents with children age 0-5, 3.7% for parents with children age 6-13, 8.5% for Black parents with children aged 13 and under, 6% for Latino parents with children aged 13 and under, and 4% for white parents with children aged 13 and under.)

#### **Key takeaways**

- ✓ Our survey finds that parents with children aged 13 and under (from here on referred to only as "parents") report experiencing a range of child care issues, including rising prices for child care, unexpected closures, and difficulty finding child care providers.
- ✓ Over one third of parents are aware of the child care funding cliff, and even with limited information, a majority of parents are concerned about the expiration of funding at the end of the month.
- ✓ When they receive more information about the childcare cliff, nearly three quarters of parents (72%) say they are concerned about the expiration of funding.
- ✓ Parents would like to see their leaders talk more about child care—a plurality agree that candidates for office are not talking about this issue enough.

### **Parents Report Experiencing a Range of Child Care Issues**

✓ Almost half of parents (45%) report dealing with at least one of the following issues with their child care:

Increased prices

Unexpected child care closures

Trouble finding child care options

- 1. Fifty-one percent of parents with very young children aged 0-5 report dealing with at least one of these issues.
- 2. Forty-seven percent of Latino parents<sup>1</sup>, 46% of Black parents, and 44% of white parents report dealing with at least one of these issues.
- ✓ One third of parents (33%) have experienced increased prices for child care in the past year.
  - 1. Thirty-five percent of Latino parents, 31% of Black parents, and 32% of white parents have experienced increased prices for child care in the past year.
  - 2. This number is even higher among parents with very young children aged 0-5 (37%).
- ✓ Eight percent of parents have experienced unexpected child care closures in the past year.
  - 1. This includes 9% of Black parents, 9% of white parents, and 6% of Latino parents.
- ✓ Sixteen percent of parents have experienced trouble finding child care options in the past year.

<sup>&</sup>lt;sup>1</sup> Latino respondents are those who answered yes to the following question: Are you, yourself, of Hispanic origin or descent, such as Mexican, Puerto Rican, Cuban, or some other Spanish background?

- 1. Nineteen percent of white parents, 15% of Latino parents, and 11% of Black parents had trouble finding child care options in the past year.
- 2. This number is even higher among parents with very young children aged 0-5 (20%).

## **Child Care Funding Cliff Awareness and Concern**

- ✓ While most Americans have not heard about the child care funding cliff, (23% of adults say they have heard a lot or some), parents are somewhat more aware, with one third of parents (34%) saying they have heard a lot or heard some.
  - 1. Even so, 18% of parents say they have not heard much about the child care funding cliff, and a plurality (42%) say they have not heard anything.

Billions of dollars in pandemic-era child care funding expired last September, and the last of the funding is set to expire on September 30, 2024. The expiration of this funding has been called a "child care funding cliff." How much have you heard about this?

- ✓ A majority of parents (61%) say they are very or somewhat concerned about the expiration of the child care funding. Adults overall are less concerned- only 46% say they are very or somewhat concerned.
  - 1. Black parents are even more concerned than parents overall 71% of Black parents say they are very or somewhat concerned about the expiration of the child care funding.
- ✓ Parents who have already heard about the child care funding cliff are also more concerned –
   83% say they are very or somewhat concerned.

# **Concern Rises When All Adults and Parents Learn More**

✓ Respondents then received more information about the child care funding cliff:

As you may know, the Child Care and Development Block Grant is the federal program that helps families afford child care and invests in the quality and supply of child care. In 2021, the American Rescue Plan Act provided a \$15 billion dollar increase to support the child care sector, allowing more parents to get off of wait lists, pay less for their care, and increased pay for child care workers. The last of this relief funding is due to expire at the end of this month.


After hearing more about the child care funding cliff, 72% of parents say they are very or somewhat concerned about the expiration of funding. Adults overall also become more concerned about the funding cliff, with 60% reporting they are very or somewhat concerned upon learning more.

1. Eighty percent of Black parents say they are concerned about the child care funding cliff after learning more.

### **All Adults and Parents Want to Hear More From Their Leaders**

- ✓ A plurality of adults (43%), including a plurality of parents (42%), agree that candidates running for office are not talking enough about the issue of child care.
  - 1. This includes a plurality of white parents (43%), Latino parents (41%), and Black parents (39%).
