Catherine previously served as Deputy Chief and Special Litigation Counsel in the Civil Rights Division of the U.S. Department of Justice, where she led numerous federal court anti-discrimination cases and engaged in large-scale civil rights investigations, including an investigation concerning the sexual abuse of incarcerated women by correctional staff in a state prison. Prior to DOJ, she engaged in civil rights-related litigation and advocacy at two other nonprofits and two private firms. Catherine is a graduate of Cornell University and Harvard Law School.

After spending 20 years working at nonprofits on behalf of incarcerated individuals and their rights, Deborah decided to form her own firm in 2019. 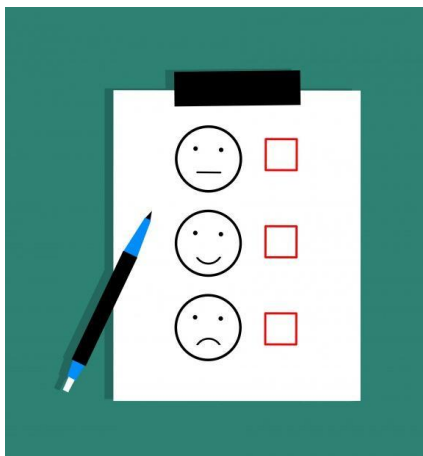
